## **Disqualification Criteria**

The following text summarises the qualification and disqualification regulations which can be seen in full on our website. Please seek advice if you think you may be affected.

A member must be aged 18 or over at the time of their election or appointment. A person cannot hold more than one membership at the same education centre.

A person is disqualified from holding or from continuing to hold office as a member if they:

- are a registered pupil of the education centre;
- are detained under the Mental Health Act 1983;
- have failed to attend meetings for six months;
- are bankrupt or have had their estate sequestrated;
- are disqualified from being the proprietor of any independent school or from being a teacher or other employee in any unit or group of units;
- are subject to a disqualification order or disqualification undertaking under companies legislation or an order concerning insolvency;
- have been removed from the office of trustee for a charity on grounds of misconduct or mismanagement or from being concerned in the management or control of any body;
- are included in the list of those considered by the Secretary of State as unsuitable to work with children;
- are subject to a direction of the Secretary of State under section 142 of Education Act 2002;
- are disqualified from working with children or from registration for child minding or providing day care;
- have received a sentence of imprisonment (whether suspended or not) for a period of not less than three months (without the option of a fine) in the five years before becoming a member or since becoming a member;
- have received a prison sentence of 2.5 years or more in the 20 years before becoming a management committee member;
- have at any time received a prison sentence of five years or more;
- have been fined for causing a nuisance or disturbance on educational premises during the five years prior to or since appointment or election as a management committee member;
- refuse to make an application for a criminal records certificate.

## In addition:

A person is disqualified from appointment as a **LA member** if they are eligible to be a staff member of the education centre.

A person is disqualified from appointment as a **community** member if they:

- are eligible to be a staff member at the education centre, or
- are an elected member of the local authority to which the Education Centre belongs

A person is disqualified from election or appointment as a **parent member** if they are:

- an elected member of the LA, or
- if they work at the centre for more than 500 hours in any year.

In addition a person may only be **appointed** as a parent member if they are:

- a parent of a registered pupil at the education centre, or if that is not possible;
- a parent of a former pupil of the education centre, or if that is not possible;
- a parent of a pupil registered at another education centre or at a maintained school in the area of the authority or if that is not possible;
- a parent of a child of or under compulsory school age, or if that is not possible
- a parent.

# Data Protection

The information that you provide on this form will be held on a computerised database maintained by the data controller (Hampshire County Council). Your data will be used in accordance with the principles set out in the Data Protection Act 1998, which protects the right to privacy of individuals whose personal details are held by the data controller. Hampshire Governor Services will only make candidate details available within the Local Authority; to Education Centres and their management committees; the Department for Education or any other body involved with the recruitment or support of management committee members in Hampshire.
